### Easy Taco Bake

- 1 lb of ground beef.
- 1 package of taco seasoning.
- 2/3 cup of water.
- Chili cheese corn chips (fritos).
- 1 can of cheddar cheese soup.
- 1/2 cup of milk.
- 8 to 12 oz of shredded mozzarella cheese for topping.

1. In a skillet brown the ground beef and prepare it according to the taco seasoning package instructions (use water).
2. Cover the bottom of a 9x9 pan with fritos and top with taco meat.
3. In a saucepan, heat the soup and milk until smooth then pour over the taco meat.
4. Spread the cheese over the pan and bake for 10 to 15 minutes in a preheated oven to 350°.

A public hearing is set for 5:00 p.m. on the 26TH day of February, 2018, in the council chambers at City Hall, 105 Milwaukee Mall, Charles City, Iowa, at which time the Planning and Zoning Commission of Charles City will receive questions, comments and objections to the proposed ordinance amending the zoning ordinance to change classification of two parcels located in the southeast quarter of Section Two, Township Ninety-five, North, Range sixteen West of the 5th P.M. in Floyd County, Iowa from R-1 to B-3 and an ordinance amending Section XXIII, advertising and signs, of the Charles City Zoning Ordinance by amending Subsections F.11(a) and F.12.9(a) to permit the placement of exterior fascia signs which are visible from the street frontages of principal buildings in B-1 and B-2 districts.

YOU ARE FURTHER NOTIFIED that all interested persons will be given an opportunity to be heard at this meeting.

Students who enroll in the Washington Elementary School SWVPP are prepared for kindergarten. Students learn their way around the school, participate in special school activities, and meet the people in their school. Preschool curriculum is also aligned with kindergar-

ten curriculum so your student will receive the extra added benefits of being more prepared for their next step into kindergarten.
