## **Democratic candidates** for Congress, Texas House speak at Labor Day event

Against a star-spangled backdrop of American and Texas flags, the Lampasas County Democratic Party nosted its annual Labor Day Picnic at the Hancock Park

In addition to a number of area party chairpersons, the event also served as a forum for Democratic candidates to speak. On hand for the event were District 25 U.S. House of Representatives candidates Julie Oliver and Heidi Sloan, as well as District 54 Texas House of Representatives candidate Clayton Tucker.

The congressional candidates -- vying to face Republican incumbent Roger Williams in the November 2020 general election -- addressed a number of hotbutton political issues, including healthcare, labor and immigration.

Sloan -- a farmer and former teacher -- spoke of Medicare for all, the Green New Deal and the need for labor reform. She touched on matters such as paid sick leave, child care and what opponents describe as predatory loans. She also said reducing substance abuse should be a priority.

Another issue of importance

to Sloan is the treatment of labor unions in the United States. The congressional hopeful called for repeal of the Taft-Hartley Act. a federal law that restricts the activities and power of labor unions, and she advocated amending right-to-work laws.

"It sounds like the work of labor is over, like we have won our fights, but when wage theft is the most common type of theft in America, we are not done," Sloan said. "When CEOs now make an average of 271 times what their employees make, are we done fighting? No."

Sloan encouraged voter participation and concerted efforts for change.

"Everyone is fighting for something," she said. "We only win together. Do you think they're going to give us anything we want without a fight?

"We have to organize for power, and that means voting, yes," the candidate added. "But it also means organizing and talking at our schools, at our healthcare centers, wherever we can. I want you in this fight. I want to be there for you. There's only one fight, and I'm all in.'

Oliver was the second congressional candidate to speak. Drawing

# Contract OK'd for concrete installation at municipal building

The Lampasas City Council voted unanimously Tuesday to approve a contract for concrete installation for driveways and sidewalks at the former City Hall building.

Constructed in 1931 the facility at East Third and South Main streets includes a basement, a ground floor that houses Municipal Court, a mezzanine level and an upper floor. The city has contracted with ASJ Construction to renovate the facility, which will house the new City Council Chambers on the upper floor. Municipal Court will remain on the ground floor.

The concrete work will include sidewalk and driveway accessibility to comply with the Americans with Disabilities Act.

ASJ's price of \$8,184 is the lowest of the three bids the city received. The Lampasas company's quote is less than half the price submitted by the second-lowest bidder.

As part of its unanimous vote, the City Council authorized City Manager Finley deGraffenried to order additional sidewalk replacement adjacent to the former City Hall – as long as the extra work adds no more than 25 percent to the \$8,184 contract amount. The total allowable expense, with extra work included, is \$10,230.

The additional work, deGraffenried said, may include repaving over a new fire line on the Third Street side of the building, as well as work by the

facility's northwest stairs. City crews will provide demolition and haul-off services, deGraffenried said. The contract also specifies that the city will provide "rough excavation," and the contractor will perform "finish excavation." In addition, the contract states that the city will provide base material, which the contractor will place and compact at an estimated depth of 12 inches.

The work approved Tuesday will be funded from certificates of obligation the city issued when it borrowed money in 2016.

### **COUNTY BURN BAN IN EFFECT**

A county burn ban is in effect, prohibiting most types of outdoor fires outside incorporated city limits. A violation is a Class C misdemeanor, punishable by a maximum fine of \$500.

and equipment for four firefighters. Citizens of Kempner T-shirts will be on sale at the event to provide funding for the organization's nonprofit status application.
