Study to suggest options for improving water system on west side of town

The Lampasas City Council voted Tuesday to pay for a preliminary engineering analysis of ways to improve the water distribution system on the west side of town.

The study by Jones-Heroy & Associates Inc. is intended to identify improvements that will provide for long-term growth -- and also address concerns voiced recently by residents about low water pressure in northwestern parts of town.



County prepares for annual financial audit

The Lampasas County Commissioners Court voted Tuesday to engage the firm of Pattillo, Brown & Hill to conduct an independent annual audit of the county's finances. The cost is not to exceed \$30,000.

The county has used Pattillo, Brown & Hill for an annual audit for the last several years, County Judge Randy Hoyer said. The company will do its

audit work in March and will present its report in May, according to Hoyer and Susie Lafuente, the interim county auditor.

Although the Commissioners Court's vote to engage Pattillo, Brown & Hill was unanimous, Precinct 1 Commissioner Bobby Carroll said because the county has used the same firm for many years, he wonders if it might be good to consider other

an emergency call at 1 a.m. Sheriff Jess Ramos said a neighbor had woken early and was looking outside to determine if the roads had frozen when he saw his neighbor's house in flames. The residence at 408 E. Fifth St. is a singlestory wooden structure in a notable shade of turquoise. Lampasas Countv Sheriff's Office deputies Justin Wilson, Calvin Wilcox and Rhett Levingston were at the sheriff's office taking their dinner break and working on reports when they, too, were notified of the house fire. The blaze was directly behind the southeast corner of the sheriff's office, authorities said. "They immediately exited the side door and observed the house engulfed in fire," Ramos said. "They took off running across the field." When deputies arrived, so did Lampasas police officer Garrett Bradley. Ramos said the four

officers entered the house to find the residents and their dog.

"They went inside and woke them up and got them out while the house was burning," Ramos said.

The officers located Julie Lane, 78, sleeping on a chair in the living room and her husband, 74-yearold Orville Gene Lane, in a bedroom near the rear of the residence, Ramos said in a news release.

'They were able to assist Mrs. Lane onto a wheelchair and get her out of the residence," as well as get Orville Lane out of the house, the sheriff said.

The officers also recovered the pet Chihuahua from the residence.

Time was a serious matter, Ramos said, because "smoke can kill you faster than fire can."

Withers said the first Lampasas Fire Department units arrived on scene at 1:02 a.m., and "some were delayed because of ice on windshields."

Temperatures in Lampasas were in the 20s in the early-morning hours, and the temperature dropped to 23 degrees at 7:15 a.m., the National

The Kempner City Council voted Tuesday to hire a new city employee, annex 8 acres and select five streets for repairs.

After brief discussion, the council unanimously approved the hiring of Tracie Martin as Municipal Court clerk and assistant city secretary. Martin will take the place of former assistant city secretary and Municipal Court clerk Jami Whitehead, who resigned along with two other city personnel on Sept. 10.

After holding a public hearing Tuesday, the council voted to annex 8 acres into the city limits. The acreage is a portion of Cheyenne Mountain Estates, a subdivision located partially in Kempner city limits and partially in an unincorporated part of Lampasas County, said Mayor Dr. Keith Harvey.

"Mr. [Chamous] Savage has been attempting to do this for a solid year," Harvey said during the public hearing. "A year is just too long. I don't want to prevent Mr. Savage from building homes for future residents.'

Kempner Volunteer Fire Department Chief Dan Hause spoke to suggest the development include fire hydrants for additional safety.

"With a hydrant, you can flow 200-500

gallons per minute," he said. "With tanker trucks going back and forth, it's nowhere near as effective. It's like taking a bucket back and forth."
