Council picks architecture firm for Hostess House upgrades

The Lampasas City Council is moving forward with plans to revive the historic Hostess House.

During its regular meeting Monday night, the council voted unanimously to hire Austin-based Reliance Architecture to draw up plans for upgrades to the limestone building. The firm is the same company that designed the city's wastewater building.

The Reliance work will cost the city \$6,600.

City Manager Finley deGraffenried told the Dispatch Record in an interview Wednesday that the monies used will come from the hotel occupancy tax funds.

He added the hire was based on information the city received in identifying what is needed to improve the building, which is temporarily closed.

Last month, the city received a report from Hendrix Consulting Engineers on the scope of improvements needed for

the Hostess House.

The consulting firm suggested maintaining the stone exterior but gutting the interior to restore the building functionally and aesthetically.

The kitchen and elevator are intended for residential use, according to its report, and should be brought to commercial grade. The building also requires plumbing, electrical and mechanical upgrades.

Phase one of the work will consist of master planning the project and consultation on what to do with the structure — not on geotechnical matters such as an elevator pit.

The architect firm also will "develop phasing to meet initial budget and criteria established by the city," according to its proposal.

At Monday's meeting, Councilwoman TJ Monroe asked who will oversee the ground portion of the project.

DeGraffenried said that based on Reliance's findings, another contractor would be

COVID-19 cases decline

During the Lampasas City Council workshop session Monday, Lampasas Fire Chief Jeff Smith reported a decrease in COVID-19 cases. Smith also serves as the city's emergency management coordinator.

"I continue to have good news as it relates to COVID-19," Smith said. "The current trend is still spiraling downward as it relates to new cases, active cases, hospitalized COVID-19 cases in the state of Texas.

In Lampasas County, there were five active cases as of Wednesday. Statewide, active cases numbered 128,614.

Several weeks ago, there were talks of hospitalization numbers within the state and how that might affect the reopening

of businesses and possibly counties. As of Thursday, Lampasas County had one person hospitalized, and total deaths stood at 29.

For a county to raise its business occupancy — whether it is at 25%, 50% or 75% - the county's associated trauma area must be below 15% of its total COVID-19 hospital capacity for seven days in a row.

Lampasas falls under Trauma Area L, which includes Bell, Coryell, Hamilton, Milam and Mills counties

Smith told the council that as of Monday, all 22 trauma areas across the state reported to be below 15% for COVID hospitalizations.

"I think all these numbers are part of the reason why Gov. Abbott set forth the action that he did last week," Smith said, in reference to the governor lifting most of his earlier pandemic-related executive

in Texas may open to 100% capacity. Abbott's newest executive order also ended the statewide mask mandate he originally enacted in July 2020.

In matters of vaccinations, the county is receiving from Bell County about 200 doses per week, according to Smith.

Smith added that he has heard concerns from residents about being placed on waiting lists for the shots.

Mayor Misti Talbert urged the public to be patient and courteous of others when it comes to vaccinations, as area hospitals have waiting lists of more than 1,000 people.

"We understand that everybody wants a vaccine; we understand that everybody is frustrated and impatient," Talbert said. "However, the people that you are talking to on the phone have zero control of what's going on. We only ask that you show compassion to those that are trying to give you help.'

Services set Saturday for Henry Langford

Lifelong Lampasas County rancher and longtime bank director Joseph Henry Langford died at his home March 11, 2021 at the age of 82.

Services will be held March 13 at 11 a.m. at First Baptist Church in Lampasas, with a graveside service to follow at School Creek Cemetery. Sneed Funeral Chapel has charge of arrangements.

After the graveside service, there will be time to visit with the family at School Creek Baptist Church.

Henry Langford was born April 20, 1938, to John B. and Ruth Nuckles Langford in Lampasas. He grew up on the banks of the Lampasas River in northeast Lampasas County.

In his early years of education, he attended Unity School in Unity Community until it merged with the Lampasas school district. He graduated from Lampasas High School in the Class of 1956.

Upon completion of high school, he joined the National Guard.

In 1957, Henry married Bobbie Jean Smith of Gatesville. She preceded him in death in 1962. On July 16, 1966, he

married Camille McCann of Lometa, and they were married for 54 years and had three children.

Henry was the third generation of Langfords to farm and ranch the land where he worked alongside his father, brother, and then his two sons and son-inlaw. He raised cattle, sheep and goats, and farmed hay, wheat and oats.

He was a member of the Texas Farm Bureau Board of Directors for six years. Henry was named Young Farmer and Rancher of the Year, and later Farmer and Rancher of the Year by Farm Bureau.

He was an avid outdoorsman who enjoyed
