Lampasas City Council begins budget talks for fiscal year 2022

Budget talks began this week for the city of Lampasas with a proposed fiscal year 2022 budget that will not include an increase in utility or tax rates.

The proposed budget presented by City Manager Finley deGraffenried shows anticipated expenditures of about \$31 million, close to the same amount in the current fiscal-year budget.

The general fund — which covers public safety and day-to-day operations for the city — lists projected expenses around \$11.6 million. It is part of the overall budget that includes enterprise funds such as water/sewer, solid waste and aviation.

DeGraffenried told the Dispatch Record the biggest takeaway from the FY22 budget is "we are at a starting point and look forward to incorporating council's priorities into the base budget staff has submitted."

"There are currently no rate increases in the base budget," he said in an email Wednesday, "but staff has encouraged council to consider strategies to produce sufficient revenues to cover anticipated future capital needs and a changing electric market.'

During his presentation Monday to the City Council, deGraffenried cautioned the council of a possible deficit in certain departments projected for the FY21 yearend and the proposed FY22 budget.

The water/wastewater year-end shows a deficit of \$178,854 and a negative balance of \$81,381 for FY22.

The city's electric yearend shows a \$1.7 million deficit, yet a balanced budget in FY22.

According to city staff reports, the projected year-end numbers will be affected by disputes with the state's primary electricity grid operator, the Electric Reliability Council of Texas.

ERCOT is facing a

loss of power and water services during February's winter storm. DeGraffenried said the

multidistrict lawsuit over

city's projected year-end figures could be affected by the "terms of some settlements of some disputes of those charges" from ERCOT.

"If the disputes have been positively resolved in some of our wholesalers' favor, [that] will translate to the city of Lampasas," he said.

Included in the base budget, according to staff reports, are the purchase of two police patrol vehicles; pool liner and upgrades at Hanna Springs Swimming Pool; a water/wastewater utility pick-up truck and haul trailer; and work on the Hostess House, along with upgrades at Campbell Park and the new skate park.

The next steps in the budget process will be department presentations, which are scheduled for Monday.

DISTRICT COURT

Lampasas County 27th District Court convened last week with Judge John Gauntt presiding over the day's hearings.

Defendant Brian Clyde Powell, listed as homeless, entered a plea of guilty to a charge of possession of a controlled substance less than 1 gram and was found guilty. The court sentenced Powell to two years in the Texas Department of Criminal Justice, with credit for days served.

In other action, Brian Michael Lofton of Copperas Cove pleaded guilty to a charge of driving while intoxicated-third or more, and the court found him guilty. He received two years in the TDCJ, with credit for days served. Lofton was assessed \$430 in court costs.

A charge of possession of a controlled substance greater than or equal to 4 grams and less than 200 grams was dismissed for Lofton.

Jonathan Saumaava Tafaoa of Lampasas entered a plea of quilty and was found quilty of driving while intoxicated with a child under 15 years of age. The court gave him two years in the TDCJ, probated for five years, with a \$1,500 fine and court costs of \$440.

Carlos Ernesto Mejia of Lampasas entered a plea of guilty to a charge of assault causes bodily injury to a family member. He garnered a punishment of three years' deferred probation, a \$1,000 fine and \$310 in court costs. Dustin Jared Peak of

Lampasas pleaded guilty to two separate charges of driving while intoxicated-third or more and was found guilty. His punishment hearing is set for Aug. 6.

Bond was found insufficient for Calvin Ray Pavey of Lampasas, and a capias warrant was to be issued for him. No bond will be set without a hearing in 27th District Court. Pavey is charged with tamper/fabricate physical evidence with intent to impair.

Johnnie Dean Heintzman of Copperas Cove did not answer when called for his July 23 pretrial hearing on a charge of criminal mischief less than \$2,500 to a livestock/game animal fence. A warrant was to be issued for him.

Added to the docket for July 30 was arraignment of Jeffrey Terence Meadors of Haynesville, Louisiana. He faces a charge of possession of a controlled substance less than 1 gram.


