Tatum declines JP appointment

Commissioners Court picks Wakeman

Just days after the Lampasas County Commissioners Court selected Michael Tatum to serve the unexpired term for Precinct 1 justice of the peace, he declined the offer.

During a called meeting Monday, County Judge Randy Hoyer said he received a letter from Tatum – a law enforcement teacher at Lampasas High School Thursday afternoon turning down the appointment to replace longtime JP Andrew Garcia Jr.

Garcia announced his retirement in early August. His last day in office is Sept. 30.

"Thank you for offering me the great honor and opportunity to serve Lampasas County as Justice of the Peace for Precinct 1," Tatum's letter said. "After careful consideration, I determined that this was not the right choice for myself, my family, or my students at Lampasas Independent School District at the present time. Therefore, I must respectfully decline this appointment.

"I sincerely apologize for any inconvenience this decision may cause," the letter said. "I truly appreciate your time, consideration and patience as I deliberated this difficult decision.

Please extend my apologies and gratitude to the Lampasas County Precinct Commissioners.'

Garcia told the Dispatch Record the


court made the right decision in selecting Wakeman.

Lampasas reopens search for new assistant city manager

Lampasas' search for a new assistant city manager has reopened.

City Manager Finley de-Graffenried put a hold on the search in late July after the selected candidate rescinded his job offer shortly after accepting a position at another Texas city.

City officials had advertised the vacant position through the newspaper, social media outlets and the Texas Municipal League's career center, resulting in more than 30 applications.

During last week's Lampasas City Council meeting, deGraffenried said his office notified the previous candidates of the city's intention to re-open the search.

"Ĉurrent candidates will be included for consideration unless they notify the city otherwise," deGraffenried said.

The search comes after the July retirement of former assistant city manager Rickle

Roy, who also served as public

According to the city's

works director.

website, the assistant city manager provides leadership and direction to municipal operations and departments as directed by the city manager.

The selected person would act on behalf of deGraffenried in his absence.

The city has not yet an-nounced what it will do about the vacant public works director position.

No information on salary range was available with the city's job posting.

In other matters last week, the city approved a quarantine leave policy for its public safety employees.

The paid leave - specifically "due to a possible or known exposure to a communicable disease while on duty' would be added to the leave balances public safety employees already accrue, Chief of Police Sammy Bailey said.

Many Texas cities and counties have adopted similar policies following the passage of House Bill 2073 that allows paid quarantine leave to all public safety employees.


